

(This document applies to all locations Owned & Operated by Wet Rentals & Tours)

WHAT TO BRING:

- Valid Government issued photo ID
- Boater's Education Certificate
- Major Credit Card for damage deposit
- Proper eye protection (Sunglasses)
- Water recommended!

PWC RULES AND REQUIREMENTS:

- 1. All guests should make a reservation prior to arrival to ensure the equipment is available for rent at the desired time. All guests participating in rentals must be able to understand and communicate English fluently.
- 2. All guests in your party **MUST** arrive no later than 30 minutes prior to the reserved departure time. Upon arrival, all guests must meet the requirements listed to participate in the rental of a PWC. If all requirements are not met, you may be subject to a non-refundable forfeit of the reservation or rescheduling of the reservation to a later date within one year from the original reservation.
- 3. All guests are subject to our **ZERO TOLERANCE** alcohol and drug policy. If you arrive intoxicated, you will NOT be allowed to participate in any operation of a PWC or any other motorized or non-motorized vessels or rental equipment.
- 4. All guests operating a PWC, **MUST** have a valid government issued photo ID including their birth date. Additionally, all PWC operators born on and after January 1, 1988, **MUST** obtain a Temporary or Permanent Boater's Education Certificate PRIOR to arrival. The original copy of your government issued ID

must be in your possession at all times while operating a PWC. A paper copy or digital copy of the Boater's Education Certificate must also be in your possession. Passengers that do not intend on operating a PWC, are NOT required to have a photo ID or the Boater's Education Certificate.

- 5. A physical copy of a major credit card or debit card is REQUIRED upon arrival to place a \$200 hold per PWC in the case of physical damages to the unit. Please keep in mind that you are liable for all damages or injuries caused by or to our PWC regardless of who is at fault, NO EXCEPTIONS.
- 6. All guests that intend on renting a PWC must be at least 18 years of age. Minors must be at least 16 years of age to operate a jet ski with a valid government issued photo ID, a Boater's Education Certificate and they MUST have their **legal guardian or parent** present the entire duration of the rental. Passengers must be at least 6 years of age and must ride behind the PWC operator at all times. Passengers **MUST** be able to comprehend the dangers of the activity, NO EXCEPTIONS.
- 7. The PWC have a weight limit of 400 lbs. The more weight you add to a PWC, the more unstable they can become. Any guest that approaches or reaches the weight limit whether it be individually or combined with another passenger will be required to operate their own PWC in order to participate in the activity.
- 8. Proper eye protection is required at all times while operating or participating in a PWC rental. Sunglasses are sufficient for the sun's powerful rays and debris that may fly into eyes at high speeds. Sunglasses and lanyards are available for sale on site or at time of booking online.
- 9. All guests including operators and passengers MUST fill out waivers and/or rental agreements to participate in any activity.
- 10. All sales are final. Any customers wishing to cancel, **MUST** provide a cancellation notice 24 hours prior to the reservation date to receive a full refund. All other cancellations will receive a one year credit. Customers will receive a one year credit in case of operator cancellation due to inclement weather or unforeseen circumstances prior to the beginning of the scheduled rental.

WEATHER & WATER CONDITIONS:

We operate between the Intracoastal waters of Indian Rocks Beach to Clearwater Beach and the Gulf of America. The conditions on the water are extremely dynamic and can

affect your ride. Always consider the weather, and the tide for the projected day of the week you are booking a reservation.

In the event of inclement weather prior to the departure time, we offer to re-book the reservation up to one year from the original booking date. There are NO REFUNDS for inclement weather cancellations.

OUR STAFF:

Our staff members are trained to keep you safe and are extremely knowledgeable of the local area and the "Rules of the road" as set by the U.S. Coast Guard. They are there to make sure you have the most fun possible while keeping you safe through the entirety of your ride. We ask that you respect our staff members and their decisions at all times. Our staff members will customize your ride to the best of their ability based on customer expectations and special requests, but we cannot guarantee all requests will be fulfilled. Photos and videos are a courtesy and typically transferred over to our customers following the end of each ride, but due to high volume of sales we cannot guarantee the same day transfer. Please note that our staff members are instructed that taking photos and videos are deemed a LAST PRIORITY in the event of inclement weather or any other foreseen or unforeseen conditions deemed unsafe at our staff member's discretion.

In this industry it is customary to tip our staff members upon return from a ride. Our staff works hard to make sure your ride is fun, safe and unforgettable so you can focus on the full experience! So please show our staff members the same hospitality they show you and don't forget, "If you LOVED your ride, TIP your GUIDE!"
